which said debtor who is not deceased has an interest or the debts owed to him/her shall be levied

of Taxation and Finance of the State of New York.

The people of the State of New York to C. Duncan Kerr, an officer or employee of the Department of Taxation and Finance:

Whereas, the above-referenced warrant in the amount of \$35,944.83 was docketed on 2/23/2007, which pursuant to statute has the force and effect of a judgment: and,

Whereas, pursuant to the authority of Tax Law Article 171-i and in accordance with Tax Law section 3032 enacted by the Taxpayer Bill of Rights of 1997, the Commissioner of Taxation and Finance has been notified that the child support collection referral, upon which the warrant was based, has been withdrawn from the New York State Department of Taxation and Finance's jurisdiction by the Office of Temporary and Disability Assistance, rendering said warrant legally unenforceable, and therefore, the New York State Department of Taxation and Finance is no longer authorized to effect collection in this matter.

The said warrant is hereby vacated and canceled, and lien against the real and personal property of the named debtor created by the docketing of said warrant is hereby released, and the clerk of Saratoga County is directed to mark the official records accordingly.

This Notice to Vacate Warrant and Release Lien relates only to the specific authorization for the New York State Department of Taxation and Finance to collect on a child support obligation or portion of such obligation, as conferred upon it by the Office of Temporary and Disability Assistance.

This Notice to Vacate Warrant and Release Lien does not affect any underlying child support order or other child support obligation of the above-named judgment debtor, nor does it alter or affect any outstanding balance due on such obligation as reflected on the records of the Office of Temporary and Disability Assistance, with respect to any such obligation, or portion thereof, that was not referred to the New York State Department of Taxation and Finance.

Now therefore, we command you to file a copy of this Notice to Vacate Warrant and Release Lien within five days after its receipt by you in the office of the clerk of the county named above, for entry by him or her in the judgment docket, pursuant to the provisions of the Tax Law.
