SOURCE OF ACTIVITY:

I OFCR LAVENSON # 30627 AND MY PARTNER OFCR PARDO #, 33800 WERE WORKING UNIFORM PATROL IN A MARKED BLK AND WHI POLICE VEHICLE. WE WERE ASSIGNED TO PACIFIC DIVISION, ASSIGNED PATROL UNIT 14A11. WE RECEIVED A RADIO CALL AT APPROX 1815 HRS AT 57 DUDLEY AVE. THE COMMENTS OF THE CALL STATED DOMESTIC VIOLENCE AND BATTERY INVOLVED.

OBSERVATIONS:

WE ARRIVED AT THE ABOVE LOCATION AT APPROX 1825 HRS; WE WERE MET BY VICT-MODICA. MODICA STATED SHE AND HER BOY FRIEND (SUSP LEVENS) LIVE TOGETHER AND HAVE DATED FOR APPROX 4 YEARS. MODICA SAID SHE AND SUSP LEVENS WERE INVOLVED IN A VERBAL ARGUMENT, SUSP LEVENS WENT INTO THE OFFICE OF THERE APARTMENT AND LOCKED THE DOOR. VICT MODICA BECAME ANGRY AND KICKED OPEN THE DOOR, SUSP LEVENS BECAME ANGRY AND STRUCK MODICA OF THE RT CHEEK WITH A PARTICILLY OPEN FIST. VICT MODICA THEN LEFT THE LOCATION AND NOTIFIED POLICE.

SUSP LEVENS STATED THAT HE DID NOT HIT VICT MODICA.

I WAS UNABLE TO OBSERVE ANY BRUISING OR REDNESS ON THE VICTS RT CHEEK.

VICT WAS ADVISED ON TRO'S.

VICT SAID SHE DID NOT WANT SUSP LEVENS ARRESTED, ADDING SHE WOULD NOT GO TO COURT. VICT ALSO SAID SHE IS GOING TO MOVE OUT IN THE MORNING.

SUSP LEVENS STATED HE WAS GOING TO NOTIFY THE MANAGER AND GIVE HIS NOTICE TO VACATE THE APARTMENT.

AS WE WERE TRANSPORTING THE SUSP TO PACIFIC STATION HE SAID THE FOLLOWING, " SHE (VICT) SAID SHE WAS GOING TO CALL THE POLICE AND TELL THEM I HIT HER, YOU KNOW THEY WILL BELIEVE ME BECAUSE I'M A GIRL".
