4. Make sure the forms are returned to court after they are served on the respondent.

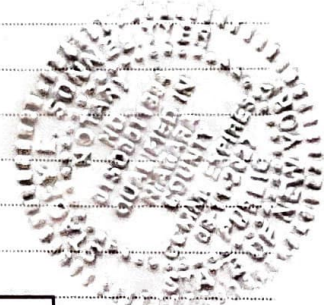

Since March of 2024 until now, I have been relentlessly stalked, cyberstalked, and harassed by Jennifer Millette-Mortensen. She began stalking me on my social media pages on Tiktok, youtube, instagram, and facebook after being instructed to do so by her neighbor and family friend Matthew John Lodice.

As time has gone on, Jennifer has continued to relentlessly stalk me and harass me, and has even gone so far as to slander me and defame me on her numerous social media accounts. She created a page called "Pro Legal Delusions" under the handle @missjganim on tiktok, in which she has posted hundreds of posts about me in which she had dedicated her entire page to slandering me and defaming me. She has posted hundreds of images, videos, and posts that include my name, likeness and image. This is unauthorized usage and I never gave her permission to use my name, likeness, or image which is protected as a registered trademark.

She has also posted hundreds of images, videos, and posts that include the name, likeness, and images of my two minor children A.L. and J.V. This is unauthorized usage and I never gave her permission to use my children's names, likeness, or their images, which are also protected as registered trademarks.

Every single day, she creates more posts about me that slander and defame me. Since then, I have received many death threats from strangers on the internet, threatening my life and the life of my minor children. She has accused me of lying about reports that I made to DCF and the police regarding my daughter being

sexually abused. I never once lied about such a serious and sensitive topic, yet she has continued to spread this dangerous misinformation about me to all of her followers, which now surpass more than 2000 on all of her various platforms. She then took it upon herself to create multiple fake pages after I blocked her and started to request to follow all of my followers, as well.

She posted confidential information including records from DCF, and belittled me for being a victim of childhood sexual abuse. She also posted several harassing and defamatory posts about my children. She has continued to stalk me and has continued to send me harassing text messages from fake burner numbers to try to cause me further distress.

Not only has she posted these on social media, but she has also directly made threats toward me, and has made it clear that she has a severe drug addiction which I worry impairs her judgment and makes her even more dangerous. I am scared for my life because she has continued to threaten and harass me from fake numbers and keeps making fake accounts. She religiously stalks my social media accounts and when I post something, within minutes she will screenshot or screen record the post and make another post in which she mocks me, makes fun of me, and incites violence against me with her followers.

Threat

Since March 2024, I have been subjected to a continuous and escalating pattern of stalking and harassment by Jennifer Millette-Mortensen. Her actions

have created a pervasive atmosphere of fear, as she has engaged in willful acts that threaten my safety and well-being. The nature of her behavior, which includes relentless cyberstalking across multiple social media platforms, constitutes a clear violation of the legal definition of stalking under Connecticut General Statutes § 46b-16a. This statute defines stalking as engaging in two or more willful acts that cause a person to reasonably fear for their physical safety. The cumulative effect of Jennifer's actions has led me to fear for my life and the safety of my minor children.

Response

In response to this ongoing harassment, I have taken several steps to protect myself and my family. These include blocking Jennifer on all social media platforms, reporting her behavior to the respective platforms, and attempting to cease all communication with her. However, despite these efforts, Jennifer has continued her campaign of harassment by creating multiple fake accounts to circumvent my blocks and further invade my privacy. This demonstrates her persistent disregard for my attempts to protect myself and highlights the severity of her stalking behavior.

Action

The actions taken by Jennifer extend beyond mere online harassment; they include the unauthorized use of my name, likeness, and that of my minor children in her posts. This unauthorized usage constitutes a violation of my rights and has

further exacerbated the emotional distress I have experienced. The creation of a dedicated page, "Pro Legal Delusions," where she slanders and defames me, is not only damaging to my reputation but also poses a direct threat to my mental health and safety. The legal standard for a civil protection order necessitates evidence of a pattern of threatening behavior, which is clearly met by Jennifer's continuous and targeted actions against me.

Consequence

The consequences of Jennifer's actions have been severe. I have received numerous death threats from strangers online, incited by her defamatory posts. This has not only affected my mental health but has also placed my children in a vulnerable position, as they too have been targeted in her harassment. The emotional toll of this situation has led to significant distress, anxiety, and fear for our safety. The legal framework for a civil protection order in Connecticut requires that the applicant demonstrate a continuous threat of physical pain or injury, which is evident in my case due to the nature and frequency of Jennifer's conduct.

Threat Assessment

The threat posed by Jennifer is further compounded by her apparent drug addiction, which raises concerns about her judgment and stability. Her erratic behavior, including direct threats and the creation of fake accounts to stalk me, underscores the potential for escalation. The TRAC method emphasizes the

importance of assessing the threat level, and in this case, the ongoing nature of her harassment, coupled with her unstable behavior, indicates a significant risk to my safety and that of my children.

Legal Justification

Under Connecticut law, I am entitled to seek a civil protection order based on the evidence of stalking and harassment I have presented. The legal standard requires that I demonstrate a reasonable fear for my physical safety, which I have articulated through the specific instances of harassment and threats I have experienced. The court must consider the totality of the circumstances, and the facts presented in my affidavit clearly establish a pattern of behavior that meets the statutory criteria for a CPO.

Emotional Impact

The emotional impact of Jennifer's harassment cannot be overstated. The fear and anxiety generated by her actions have disrupted my daily life and that of my children. I find myself constantly vigilant, fearing further harassment or potential physical harm. This emotional distress is a critical factor in justifying the need for a civil protection order, as it directly correlates with the legal requirement to demonstrate a continuous threat of physical and emotional harm.

Need for Immediate Relief

Given the ongoing nature of the harassment, I am requesting immediate relief through the issuance of a civil protection order. The court's ability to grant

ex parte relief is essential in cases where there is a demonstrated immediate threat. The urgency of my situation is heightened by the potential for escalation in Jennifer's behavior, and it is imperative that the court act swiftly to ensure my safety and that of my children.

Conclusion

In conclusion, the evidence presented in my affidavit clearly demonstrates the necessity of a civil protection order against Jennifer Millette-Mortensen. Her persistent stalking, harassment, and the threats made against me create a legitimate fear for my safety and that of my children. The legal standards for obtaining a CPO in Connecticut are met in this case, and I respectfully request that the court grant my application to protect myself and my family from further harm. This structured approach using the TRAC method will help articulate the legal justification for the civil protection order while presenting a professional and compelling case to the court.





This could be a local law enforcement agency or the sheriff in the county where you're serving the order. Laws vary by state.
